## **LEA Plan for Use Of Funds**

1. The District will use the funds to implement prevention and mitigation strategies in the the following ways:

- 1. Continue to provide all necessary supplies, equipment and PPEs to maintain a safe workplace environment as well as continued PD for all staff on proper use of relevant procedures necessary.
- 2. Continue to update the District Re-Opening Plan according to all directives from the CDC, State Health Department, the NJDOE and the local Board of Health.
- 3. High School facility repairs and improvements to enable the operation of schools to reduce risk of virus transmission and exposure to environmental health hazards, and to support student health needs. Inspection, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and non-mechanical heating, ventilation, and air conditioning systems, filtering, purification, and other air cleaning, fans, control systems, and window and door replacement.
- 2. How the LEA will use the funds it reserves under section 2001(e)(1) of the ARP Act to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year; ([count] of 2000 maximum characters used)

- 1. Summer Enrichment/Learning Program will be enhanced for elementary, MS, and HS students with an emphasis on learning acceleration, credit recovery programs, online learning platforms and fine/practical arts curriculums. The NJ SEL Proficiency Standards will be infused daily to promote positive behaviors, increased academic success and community involvement. These Elementary, MS and HS programs will support all students, including homeless, in foster care, ELL, disadvantaged and disabled through whole group literacy instruction, small group support and 1:1 support.
- 2. An After-School/Evening Art Enrichment program will be enhanced for elementary, MS, and HS students with an emphasis on fine and practical arts curriculums. Each session will provide an opportunity to highlight student's work within the context of the that night's theme.
- All academic levels, educators and families will benefit from coaching and PD to increase and improve the level of provided support through after-school tutoring and enrichment programs with an emphasis on providing whole group literacy, small group instruction and 1 1 support for all students, including homeless, in foster care, ELL, disadvantaged and disabled. Extracurricular activities such as book clubs, STEAM activities, and literary programs will be provided to students and families to foster a sense of positive engagement between school and the community.
- 3. How the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) of the ARP Act; and ([count] of 2000 maximum characters used)

The Covid-19 pandemic has impacted the staff, the students and their families in a number of different ways with a varying levels of intensity. As a result of this pandemic the District sees the need to provide all necessary services required, both in district and utilizing outside providers when necessary, to alleviate the stress, anxiety or any other mental health need our educational community requires to move forward.

The Garfield School District will develop and implement Professional Development sessions for the entire staff, student body and their families addressing the needs of students within the Social Emotional Learning Spectrum. Topics to be covered will include: Bias, Empathy, Dignity, Equity, Wellness, Trauma-informed practices, Culturally Responsive Practices, and Restorative Practices.

Continue with our SEL Community Outreach Program.

The Garfield School District will continue to provide necessary interventions and support to all at-risk students, their teachers and their families. The district recognizes that all students may be at risk every day. The primary objective of the program is to improve communication between the Garfield School District and all community stakeholders including, but not limited to, parents, guardians, residents and business owners. Tasks include:

Develop, plan and coordinate community outreach programs and activities

Develop and prepare both online and in person (when possible), community presentations

Deliver presentations to parents, guardians, and students

4.
